Fees and Rules for Members to use their own Jon Boats and Kayaks

Lake Kandle will now be providing a limited amount of dock space for member's Jon Boats and Kayaks. No other personal vessels will be permitted.

Jon Boats:

Seasonal Jon Boats will be accessed at former campsites F6, G4, G5. Daily rentals will be docked at the public dock near the launch ramp.

Kayaks: 10 Seasonal Spaces.

Kayaks will be stored and launched from former campsites E8 and E10.

Boaters must provide their own lifejackets and oars. Boat passes must be visible on vessels.

Boat Pass Fees:

\$ 80 Season

\$ 25 Daily (reservations must be made 24 hours in advance)

\$ 10 Life Jacket Rental per jacket, per day



BOAT RULES:

FOR MEMBERS ONLY. GUESTS WILL NOT BE PERMITTED TO BRING BOATS. LAKE KANDLE IS NOT RESPONSIBLE FOR DAMAGED/STOLEN BOATS OR EQUIPMENT.

1. No children under the age of 13 may be on a boat without an adult present on board.
2. Minimum Age to operate an electric 12 volt motor is 13 years of age.
3. All children 12 years of age and younger must wear a personal flotation device. Although persons 13 years of age or older and persons not on personal watercraft are not required to wear a personal flotation device, there still must be a wearable personal flotation device onboard the vessel that is the correct size for each person. This wearable personal flotation device(s) must be readily accessible and in serviceable condition. Life Jackets can be rented at the office for a fee.
4. Boat may only be used during membership hours of operation. To come in earlier than 10am, boater must receive permission 24 hrs in advance. No members are permitted on the property after 8:30PM.
5. **Boat must be taken off property by Labor Day.** Members will not be permitted to use the boat on the lake once the swim season has ended.
6. Children under the age of 13 must be accompanied by an adult to be in the campsite areas and docking areas.
7. For daily renters, dock reservation must be made at least 24hrs before use. If the boat has not be taken from the property, the daily docking fee will be charged to the member's account for each day it remains on the property.
8. Neither the dock space, nor the boat may be sublet. The boat and the space provided are only to be used by the renter.
9. Boaters must remain seated and there shall be no swimming from the boat.
10. All trash and refuse must be placed in a trash receptacle. The dock area shall be kept clear of litter and trash. There are several dumpsters located throughout the campground for your convenience.
11. Violation of these policies can result in a revoked boat pass without refund as well as possible termination of membership.
