Guests (ages 3 and older): \$10 Weekdays \$15 Weekends and Holidays

- **Limit 4 per day.** 24hr advanced permission required for additional guests. No extra guests on Holidays.
- Guests may not be on premises at anytime without the host member present.
- Unregistered guests will be denied entry. Inform office or gate staff of guests upon arrival.
- Guest fees are non-refundable. Please check weather conditions prior to inviting guests.

Pavilion Reservation/ Picnic Reservation: (Reservations start being taken April 1st)

- \$25 Non-refundable booking fee. Fee transferrable to Lake Kandle credit for applicable cancellations. Members have until 11AM day of picnic to cancel without penalty. Only one reservation permitted per event
- Limited to 35 non members.
- All guests subject to guest fee. Member may elect to have gate staff run a guest fee tab and pay by day's end or have guests pay their own way. Guest lists are ideal for easy entry and settlement. Guests may not be on premises without host member present for duration of guest's visit.
- Lake Kandle will not deal with 3rd parties. Reservations and guest tabs exclusively conducted with MEMBERS only.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT
("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in the Lake Kandle, Inc facility activities ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I understand the nature of such activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity. FULLY UNDERSTAND THAT: (a) Lake Kandle, Inc ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.
