**SINGLE MEMBERSHIP**

Single membership for one person age 15 or older.

**TWO PERSON MEMBERSHIP**

Independent of relationship or household, the two person membership can be purchased for any two people. However, at least one person on the membership must be an adult (18 or older).

**FAMILY MEMBERSHIP**

The Family Membership includes spouse and all legal dependent children. Extended family members, regardless if they reside at the same address, cannot be added to the Family Membership Offering\*.

\*Exception: If dependent children are in a single parent household, an adult relative may be designated as spouse on the membership. Single parent family memberships may not be combined.

("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in the Lake Kandle, Inc facility activities ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I understand the nature of such activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
